

CALL FOR APPLICATIONS FOR ENROLMENT INTO THE BACHELOR OF LAWS (HONS) PROGRAMME ON ECONOMIC FEE PAYING BASIS

The School of Law, Economics and Government at the University of Malawi, invites applications for enrolment into the Bachelor of Laws (Honours) Programme for the **2025/2026** academic year on economic fee paying basis. The following are the admission options, eligibility criteria, and processes for entry into the programme.

1. ENTRY OPTIONS

The programme has two entry options:

- a) At first year;
- b) At any appropriate year.

2. ENROLMENT

Enrolment into the LLB (Hons) Programme is subject to selection by the University through the School.

3. ENROLMENT AT FIRST YEAR

An applicant is eligible to be considered for selection if she or he has at least six credits, including English, obtained at one sitting in her/his IGSCE, MSCE, or any equivalent examination system recognised by the University of Malawi **and** meets either set of the criteria below:

Set A (Internal Candidates)

- a) At least a cumulative credit average grade (or GPA of 3.00) after her/his first year of her/his degree programme in any Malawian public university; **or**
- b) Three A-Level passes with a minimum of two Bs and one C obtained at one sitting; or

Set B (External Candidates)

- a) A first degree with at least a credit from the University of Malawi or universities duly recognised by the National Council for Higher Education; **or**
- b) A diploma in law with at least a credit from a tertiary institution affiliated to and recognised by the University of Malawi.

4. ENROLMENT AT ANY STAGE OF THE PROGRAMME

An applicant is eligible for enrolment at any stage of the programme if she or he:

- a) Is pursuing a professional law degree qualification in a University recognised by the National Council for Higher Education; and
- b) Has passed an assessment exercise appropriate for the year of desired entry.

5. MODE OF APPLICATION AND DEADLINE

- Expression of interest
- Proof of ability to pay tuition fees of MK3,500,000 per academic year
- Proof of a deposit of a non-refundable processing fee into the following bank account:

Law and Development Unit, National Bank of Malawi, Zomba Branch, Account Number 297108. The processing fee for internal applicants is MK20, 000.00, and MK30, 000.00, for external applicants.

Candidates who already expressed interest in the Economic Fee Paying option during the recent application process do not need to apply again.

Female candidates are encouraged to apply.
